



# TENNIS WORLD COVID UPDATE

17<sup>th</sup> September 2021

Dear Members, Students and Families,

As was announced by the ACT Government this week, from this Saturday, 18<sup>th</sup> September, tennis will be permitted for the purpose of exercise and recreation.

At this stage, this does not include or allow coaching, organised social play or competitive tennis, however it does mean that people can arrange with friends and/or family to use tennis as their form of exercise during this extended lockdown.

Tennis World will be following the advice and guidelines from the ACT Government and also Tennis ACT. Some of the key points to be aware of are as follows:

1. **Bookings must be made online** via [www.tennisworld.net.au](http://www.tennisworld.net.au) before attending the venue. No 'walk in' bookings will be permitted. **A maximum of 1 hour per person per day.**
2. All participants must **scan the CBR QR code** when arriving at the venue, prior to proceeding to the court.
3. Use **hand sanitiser** upon entry.
4. All visitors must **wear a face mask** whilst onsite, but may remove it when on court participating in strenuous exercise.
5. A maximum of **4 people** per court per booking.
6. A maximum of **4 tennis balls** per court.
7. The Pavilion will be closed and there will be **no access to toilets.**
8. There is a 15-minute buffer between bookings. **Please play and leave**, do not mingle after your booking.
9. **Spectators are not permitted.** 1 parent may supervise their child/ren playing as Tennis World will not be responsible for the supervision of players.

## What does this mean for Tennis World Members?

- To welcome our valued members back to Tennis World, all memberships will be **active from Friday 17<sup>th</sup> September** allowing court bookings to be made in line with your current membership category however Members **will not be charged for Saturday 18<sup>th</sup> September to Sunday 26<sup>th</sup> September.**
- If you wish to **keep your membership suspended**, please notify us in writing by email to [tennisworldcanberra@tennis.com.au](mailto:tennisworldcanberra@tennis.com.au) by no later than 7.00pm on Friday 24<sup>th</sup> September 2021.
- On Monday 27<sup>th</sup> September, the **regular direct debit will be processed** which will be for the period of Monday 27<sup>th</sup> September to Sunday 10<sup>th</sup> October 2021 and will be charged for all membership categories.
